

MAP REWARD TRAFFIC BONUS TERMS AND DISCLAIMER

Terms

1. These terms are supplemental to the Affiliate Bonus Terms and Conditions, and should be read in conjunction with that document.
2. Qualifying Transactions: A Purchase by You in cleared funds of any of the following MAP memberships at the dates indicated:
 - MAP Backer: before the close of MAP Phase 2.
3. For the avoidance of doubt, a purchase by You of a MAP VIP package is not a Qualifying Transaction.
4. For the purposes of this document, MAP members who complete any Qualifying Transaction are "Eligible Members".
5. The Affiliate reserves the right to modify the eligibility criteria outlined in Terms 2 and 3 at any time.
6. The Affiliate shall invest his earnings from two-tier MAP commissions in delivering traffic ("The Traffic") to the MAP One Links of the Eligible Members.
7. Allocation of The Traffic between the Eligible Members will be weighted as follows:

Backers/Platinum members	5
Gold members	3
Silver members	2

Explanation: for every 2 clicks delivered to one Silver member, at least 3 clicks will be delivered to one Gold member, while at least 5 clicks will be delivered to one Backer/Platinum member.
8. The Affiliate guarantees no precise allocation of The Traffic. You agree to never dispute the accuracy, fairness or propriety of any allocation of The Traffic to any Eligible Member, including You.
9. The Traffic shall be sourced from one or more reputable providers of The Affiliate's choosing.
10. The Affiliate shall source The Traffic globally from one or more reputable providers. The Affiliate reserves the right to determine from where The Traffic will be delivered.

11. Provided that The Affiliate has earned sufficient two-tier commissions to invest in The Traffic, Delivery of The Traffic shall start after the commencement of Phase 3 of MAP.

12. Following Your completion of a Qualifying Transaction, You must either maintain or upgrade Your MAP subscription without interruption to remain an Eligible Member. Cancellation, revocation or downgrade of Your subscription will result in the forfeiture of Your right to receive The Traffic, *even if You upgrade again at a later date.*

13. You must deliver the text of Your MAP One Link to The Affiliate's support desk as soon as possible after completion of a Qualifying Transaction.

14. You are wholly responsible for quoting to The Affiliate the correct text of Your MAP One Link. The Affiliate shall in no way be responsible if any error by You in either quoting or verifying You MAP One Link results in the delivery of The Traffic (or a portion thereof) to an invalid or incorrect destination.

15. In the event of technical issues or outages affecting the MAP squeeze page and/or the opt-in process, The Affiliate will make reasonable endeavors to suspend delivery of The Traffic pending resolution of the issue. However, the Affiliate is under no obligation to do so, and is not otherwise responsible for any lost conversions as a result of circumstances beyond The Affiliate's control.

16. The Affiliate reserves the right to terminate your rights to receive The Traffic at any time without compensation.
