

AFFILIATE BONUS TERMS AND CONDITIONS

Definitions

“You”/“Your”/“Yourself” = The customer of The Vendor referred by The Affiliate.

“The Affiliate” = Duncan Whitmore, his agents, employees, and representatives, plus any entity owned by or other otherwise associated with Duncan Whitmore.

“The Vendor” = The merchant transacting with You for sale of The Product to You.

“The Product” = The product purchased by You from The Vendor following a referral by The Affiliate.

“The Link” = The Affiliate’s referral link for The Product.

“The Bonus” = The sum total of all bonus products and services offered by The Affiliate to You following a referred sale of The Product by The Customer from The Vendor.

“Qualifying Transaction” = A transaction for purchase of The Product by You from The Vendor via The Link, and/or any other stipulation outlined in The Bonus offer.

Terms

1. Upon Your settlement of the Qualifying Transaction in cleared funds with The Vendor for The Product, the Affiliate shall grant You access to The Bonus within a reasonable time, or as otherwise specified.
2. You will, upon request by The Affiliate, furnish The Affiliate with proof of the Qualifying Transaction. The Affiliate reserves the right to withhold from You access to The Bonus in the absence of such proof, or deny access entirely if proof is delivered more than six months after the Qualifying Transaction.
3. The Affiliate reserves the right to withdraw any offer to deliver The Bonus at any time prior to You completing a Qualifying Transaction.
4. The Affiliate reserves the right to remove or substitute The Bonus for a suitable alternative from that offered. In particular, where The Bonus, or an element thereof, consists of personal services to be rendered by The Affiliate, should The Affiliate become indisposed, or provision of The Bonus be otherwise

subject to force majeure, or Your claim for The Bonus is made more than six months following the Qualifying Transaction, then The Affiliate is under no obligation to render the aforesaid services to You.

5. The Qualifying Transaction is governed by The Vendor's terms and conditions. The Affiliate shall bear no liability or responsibility for any aspect of the relationship between You and The Vendor.

6. In the event that, for whichever reason, You receive a refund for The Product (or the Qualifying Transaction is otherwise reversed), You will forfeit all rights and privileges over The Bonus. Where The Bonus, or an element thereof, consists of irrecoverable services rendered to You by The Affiliate, You will compensate The Affiliate for the aforesaid services within seven working days or as otherwise agreed.

7. Following delivery, You shall enjoy personal use rights over The Bonus unless specified otherwise.

8. Your rights and privileges over The Bonus are not transferable to any other individual or entity, nor may they be exchanged for cash.

9. The Affiliate's offer to deliver You The Bonus constitutes a discretionary gratuity upon Your completion of The Qualifying Transaction. Settlement by You of The Qualifying Transaction creates in You no actionable, legal right to delivery of The Bonus.

Your Agreements

By accepting The Bonus You agree:

a) To abide by all the terms in this document, and in any supplemental document specific to a particular Bonus.

b) To abide by all of the terms and policies of The Vendor, and the terms of the Qualifying Transaction.

c) That the Affiliate reserves the right to terminate Your rights and privileges over The Bonus without refund or any further obligation for any breach, by You, of any of these terms and/or of The Affiliate's rights with regards to Your use of any product or service provided to You by The Affiliate.

d) To fully compensate The Affiliate for any liability incurred by The Affiliate as a result of Your actions in consuming The Bonus, illegal or otherwise.

e) That, in the event of a conflict between Your permissions, privileges, benefits, and restrictions specified in this document and any other representation of the same, the terms in this document shall prevail.

f) That, by exercising your rights and privileges over The Bonus, You agree to abide by these terms.

g) That if You do not agree to these terms then You will cease to exercise Your rights and privileges over The Bonus.

h) That Your failure to read or understand these terms in their entirety will not void Your agreement to the provisions set out therein.
