

EASY COMMISSION FUNNEL BONUS TRAFFIC TERMS AND DISCLAIMER

Terms

- 1. These terms are supplemental to the Affiliate Bonus Terms and Conditions, and should be read in conjunction with that document.
- 2. Qualifying Transaction:

For 100 clicks, a Purchase by You in cleared funds of the following:

• Internet Income System – monthly, annual, or lifetime Affiliate Pro subscription.

AND

A Purchase by You in cleared funds of ANY TWO of the following:

- Sendshark monthly or annual membership.
- LiveGood monthly or annual membership + affiliate status.
- Fast Forced Profits Single Pack or Tri-Pack
- LeadsLeap Pro membership

For an additional 100 clicks, a Purchase by You in cleared funds of the following:

• Internet Income System – annual Affiliate Pro subscription.*

For an additional 200 clicks, a Purchase by You in cleared funds of the following:

Internet Income System – lifetime Affiliate Pro subscription.*

For an additional 50 clicks, a Purchase by You in cleared funds of the following:

Sendshark – annual membership

For an additional 50 clicks, a Purchase by You in cleared funds of the following:

LiveGood – annual membership + affiliate status

For an additional 20 clicks, a Purchase by You in cleared funds of the following:

Fast Forced Profits – Tri-Pack



- *Only one upgrade selection for the Internet Income System may be claimed as part of the Qualifying Transaction.
- 3. The Affiliate shall arrange for the number of clicks for which You are eligible ("The Clicks") to be delivered to Your ECF referral link.
- 4. The Clicks shall be sourced from one or more reputable providers of The Affiliate's choosing.
- 5. The Clicks shall be sourced from "Tier-1" English-speaking countries, namely the United States of America, Canada, the United Kingdom, Australia and New Zealand. However, The Affiliate reserves the right to deliver Traffic from other locations.
- 6. Delivery of The Clicks shall start on a date of The Affiliate's choosing after Your Qualifying Transaction has been verified.
- 7. Delivery of The Clicks will take at least thirty calendar days from the date on which the first click is delivered.
- 8. You are wholly responsible for quoting to The Affiliate the correct text string of Your ECF referral link.

The Affiliate shall in no way be responsible if any error by You in either quoting or verifying Your ECF referral link results in the delivery of The Clicks (or a portion thereof) to an invalid or incorrect destination.

- 9. In the event of technical issues or outages affecting the ECF capture page and/or the opt-in process, The Affiliate will make reasonable endeavors to suspend delivery of The Clicks pending resolution of the issue. However, the Affiliate is under no obligation to do so, and is not otherwise responsible for any lost conversions as a result of circumstances beyond The Affiliate's control.
- 10. Supplemental to Term 4 of the Affiliate Bonus Terms and Conditions, in the event that the wholesale prices of sourcing The Clicks should rise to a level that (in the view of The Affiliate) renders their delivery uneconomic (or if The Affiliate should otherwise encounter unforeseen difficulties in sourcing The Clicks), The Affiliate reserves the right to either delay delivery of The Clicks or to offer a reasonable substitute bonus product.
